In all other cases, we will not sell, rent or transfer your personal data to third parties unless you give your consent and a data processing agreement has been concluded with the third party in question, which contains the necessary guarantees regarding confidentiality and privacy-compliant treatment of your personal data.

Storage of personal data

Unless a longer retention period is required or justified by law or by compliance with another legal obligation, we will retain your personal data only for the period necessary to achieve and fulfil the purposes described in this Privacy Statement.

In the context of processing your personal data, you have the following privacy rights:
